We know that our performance will be measured not only by our success on the field of play or our profitability as a business but also by our impact on the quality of life in our communities and on the environment we share.

St Mirren F.C. recognises its responsibility to ensure a safe and healthy environment and will endeavour to maintain sound environmental performance through the continued maintenance of our proactive environmental management system, which is integrated into our overall business activity.

The objectives of this policy statement will continue to be achieved by having clearly outlined management responsibilities and by promoting employee involvement through increased awareness, training and instruction.

The policy aims to promote employee involvement through increased awareness, training and instruction. Employees are asked to help St Mirren F.C. become more environmentally friendly by conserving natural resources, by minimising the use of non-renewable materials, by recycling materials, by minimising energy use and by using recycled products and packaging.

We. As a club, aim to minimise significant environmental impacts and ensure legal compliance.

We will continue to strive to avoid polluting the land, air or water and we will take all reasonable steps to prevent pollution at its source. We will avoid hazardous processes or materials where suitable alternatives are available.

We will aim to conserve natural resources by minimising the use of non-renewable materials, by recycling materials such as bottles from our hospitality/function suite, by minimising energy use, by using recycled products and packaging. We will continue to seek waste minimisation opportunities.

We will continue to develop plans to improve the environmental performance of our suppliers and contractors where appropriate. We will look for opportunities to promote environmental best practice initiatives with our commercial partners. We will

We will continue to ensure environmentally sound landscaping and ground maintenance at all our sites, and will ensure that refurbishment schemes and new construction meet the appropriate environmental standards.

Detailed environmental objectives and targets have been set with the aim of achieving continual improvement in our performance. We will promote our environmental commitment to attract customers to our venue and investors to our company

This policy will continue to be reviewed on a regular basis, and will be brought to the attention of all employees and made available to all stakeholders including the general public either via our web site St Mirren Football Club or on request

We will regularly audit our compliance with legislation and with this policy, measure our progress and continually improve wherever economically practicable.
